MEMBERSHIP CATEGORIES/AMOUNTS:

REGULAR MEMBERS: \$150 is now due for RSA Regular Members Dues (\$40) and subscription (\$110) to the journal *Alcoholism: Clinical and Experimental Research*.

POSTDOCTORAL MEMBERS (no more than 4 years past their degree) pay the same dues (\$40) as regular members, but receive a discount for the journal (not optional) - their combined dues/subscription total \$100.

ASSOCIATE MEMBERS' dues are \$40, with the journal optional at an additional charge of \$110

STUDENT MEMBERS' dues are \$20, with the journal optional at an additional charge of \$60

EMERITUS MEMBERS are not required to pay dues, but pay full price (\$110) for the journal (subscription is optional). If you wish to retain your membership, but not subscribe to the journal, let the RSA office know so we can keep your file current.

Fetal Alcohol Spectrum Disorders Study Group 2010 Membership Form

FASDSG is growing! We are increasing in members as our annual Conference is attracting more investigators. The number of speakers and travel awards for the meeting has grown. In order to expand our support role for FASDSG investigators and for the community, we are increasing our networking activities with other FASD groups and are significantly upgrading our website. Our success has been fueled by a grant from NIAAA. We have also benefited from the long term support of the Research Society on Alcoholism, of which we are a satellite organization.

At our annual Conference last June, the FASDSG membership voted unanimously to levy a modest membership fee to defray the expenses of our growing activities. This email and form request your membership information and dues payment. The request and payment is being coordinated with your 2010 membership renewal for RSA.

What will your dues support? One purpose of the membership dues is to underwrite our new website. Ultimately it will feature a password-protected domain in which members can post job opportunities, request materials, discuss issues relevant to FASD, and other services. The website will also help us to better manage our memberships and communications, make it easier to submit travel award requests and abstracts for our annual meeting, etc. Currently all this is being managed manually without administrative support. Advances in web technology will automate much of this for FASDSG and allow its members to focus on our science and the Conference itself.

Registration for the Conference will be handled separately, at the time of registration for the RSA Annual Meeting in the Spring. As with past practice, the Conference registration fee will be used exclusively to support part of the cost of the Conference itself. Members will be granted a reduced cost for registration at the 2010 Conference compared to non-members. In addition, members will qualify to submit abstracts for FASt Data presentation and qualify for Student/Postdoctoral Fellow Travel Awards. As members suggested at this year's Conference, separating membership dues and the meeting registration will enable researchers to stay active and support the FASDSG even when they are unable to attend the Conference itself.
